**1. Call to Order.**

Mayor Roper called the meeting to order at 6:30 p.m. gave the open meeting statement and announced that a quorum of the council was present. City Staff present were Tom Dickson, Monica Hendrix, Matt Huffhines, Linda Klump and Joseph Pace.

**2. Visitor and Citizens Forum**

Gary Cox spoke and brought photos of areas around town that he feels need attention. Cox informed council of the old business district sign, concrete slab, rebar, chunk of asphalt and other debris that is causing a sink hole in the N. Bordon Street right-of-way that he mows. Cox also pointed out the "oopsies" of the lights on the bridges that are off center and the turn off of the Frontage Road onto E. Center Street that is too narrow because of the wheelchair ramp and sidewalk. Cox says you turn into the lane of the oncoming traffic if you aren't careful or if you are pulling a trailer, you will run over the curb.
