MINUTES

- 1. Call to order.
 - a. Pledge of Allegiance

Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible.

Mayor Roper called the meeting to order at 6:31 p.m. Council members present were Mayor Chuck Roper, Mayor Protem Bill Coleman, J. Fagner and Jennifer Grimm. Kelly Yarbrough arrived at 6:49 p.m. Jeff Linnstaedter was absent. Constituting a quorum.

City Staff present were Tom Dickson, Monica Hendrix, Kevin Neal and Joseph Pace.

2. Visitors and Citizens Forum

At this time any person with business before the Council not scheduled on the agenda may speak to the Council. Comments are limited to three (3) minutes, and this time is not transferable. No formal action may be taken on any of these items at the meeting. This forum is limited to a total of 30 minutes.

No visitors spoke.

3. Approval of Minutes:

a. October 23, 2018

A motion was made by Jennifer Grimm and seconded by Bill Coleman to approve the minutes as submitted.

All in favor, motion carried.

4. Discussion and possible action authorizing City Manager Joseph Pace as the legal signer for the merchant credit card processing account.

Monica Hendrix informed council this action will remove retired City Manager Billy Clemons and replace him with current City Manager Joseph Pace as the legal signer for the merchant credit card

machine. The BASYS Processing Company called to inform us of savings on the monthly maintenance fees and it was discovered that Billy Clemons was never replace with Joseph Pace. J. Fagner motioned to authorize City Manager Joseph Pace as the legal signer for the merchant credit card processing account. Jennifer Grimm seconded the motion. All in favor, motion carried.

- 5. Discussion and possible action on Ordinance 2018-1119-01 authorizing and allowing, under the act governing the Texas Municipal Retirement System, "updated service credits" in said system on an annual basis for service performed by qualifying members. This ordinance is required to update the match for retirement from 1 ½ to 1 to 2 to 1 match. This was approved by council with the 2018-2019 FY Budget. This ordinance will take effect in January 2019. A motion was made by Bill Coleman and seconded by J. Fagner to approve Ordinance 2018-111901 authorizing and allowing, under the act governing the Texas Municipal Retirement System, "updated service credits" in said system on an annual basis for service performed by qualifying members. All in favor, motion carried.
- 6. Discussion and possible action on authorizing the City Manager to enter into an agreement with the NewGen Strategies & Solutions to complete the Wholesale Water Contract Support and Rate Revision Services.

7. Discussion and possible action changing the December 2018 city council meeting date to December 10, 2018 at 6:30 p.m.

There was discussion last month at the joint Council Workshop with the Lorena Planning and Zoning Commission to change the regular December City Council meeting date to December 10th to allow for a joint public hearing with the P&Z.

A motion was made by Jennifer Grimm and seconded by J. Fagner to change the December council meeting date to December 10th. All in favor, motion carried.

8. Police Department Activity Report.

Tom Dickson reported that Police Officers have been in training during the month of October and training is complete. Officers were recertified in ASP, pepper spray and defensive tactics. PD is preparing for Thanksgiving this week and will have extra officers on duty to work the interstate. On November 1st the PD and Volunteer Fire Department made the switch to fulltime radio dispatch to Woodway Public Safety and "so far so good".

There were 316 calls by type in October and 402 citation issued.

9. Public Works Report.

a. TIRZ #1 East phase 1 generator update

Kevin Neal reported the generator has been repaired and did not have to be replace. The issue was with the wiring harness and a sensor had to be replaced. The TIRZ Board has already approved a letter of acceptance on the project.

b. Municipal Solid Waste update

The trash truck is down again and Neal thinks it the hydraulic pump. A new pump is approximately \$3,200.00 plus labor. There is no estimate yet on the cost for labor. Allied Waste will be picking up the trash for Lorena until the truck is repaired.
